From M25

- Leave the M25 at junction 28 (signed Chelmsford, Romford and A12).
- Join the A12 towards Chelmsford.
- Remain on the A12 until junction 15 (Webbs Farm Interchange).
- At the roundabout at the bottom of the slip road, take the second exit onto A414 (Three Mile Hill) towards Chelmsford.
- Take the second exit at the roundabout.
- Pass the bowling alley on the left and at the next roundabout take the first exit onto A1016 (Westway).
- Continue onto Waterhouse Lane and then Rainsford Lane.
- Follow the west end theatre and rail station signs into Rainsford Rd past County Hotel and left into Broomfield Rd.

From A12 (Colchester)

- Leave the A12 at junction 17 (Southend/Chelmsford).
- Join A1114, the roundabout and flyover leads into Parkway.
- Follow the west end theatre and rail station signs into Rainsford Rd past County Hotel and left into Broomfield Rd.

By Train

- Chelmsford receives services from London Liverpool Street, Colchester, Ipswich, Norwich, Bury St Edmunds and Peterborough.
- On Leaving the station, turn right into Duke Street and continue under the bridge.
- At the traffic lights turn right onto Broomfield Road, and continue to the next set of traffic lights. We are on the right.

Car Parking

- Public car parks are situated locally to the office, as displayed on the map below.
- On street Pay and Display is available in the streets surrounding the office.

- If using Sat Nav, enter CM1 1SW which will direct you to Broomfield Road.
